

## **Membership Agreement**

### **WiseNetwork Park Club**

This Membership Agreement (“Agreement”) is entered into between **WiseNetwork Park Club** (“the Club”) and the undersigned member (“the Member”).

By completing registration and accepting these terms, the Member agrees to the following:

#### **1. Membership Eligibility**

Membership at WiseNetwork Park Club is subject to approval by the Club. The Club reserves the right to accept or decline applications at its discretion.

#### **2. Membership Categories**

The Club offers several membership types, including but not limited to:
